THESE CURRENT DIRECTIONS ARE NOT REASONABLE OR PROPORTIONATE TO ANY RISK AND THEREFORE ARE **UNLAWFUL**. (S.13 HUMAN RIGHTS ACT).

UNDER S. 47 OF THE STATUTORY INSTRUMENTS ACT QLD 1992 THESE DIRECTIONS MUST BE PUBLISHED IN THE GOVERNMENT GAZETTE. THEY HAVE NOT BEEN AND THEREFORE ARE **UNLAWFUL**

ANYONE ATTEMPTING TO ENFORCE UNLAWFUL DIRECTIONS WILL BE GUILTY OF AN OFFENCE AND PERSONALLY LIABLE.
